




Maintenance & Operations Expenditure by Object



Maintenance & Operations Expenditure by Function




M&O, District Additional Assistance, Adjacent Ways and Debt Service by Funding Source









Unrestricted Capital Outlay





Funds 020-799 by Function Excluding Debt Service


